Previous Tennessee Valley Authority (TVA) Organization Topical Reports (e.g., Ref. 1) have been submitted annually to ensure that the submittal requirements in accordance with 10 CFR 50.71, "Maintenance of records, making of reports," paragraph (e) are met for each operating plant. TVA's Organization Topical Report provides organizational descriptions for the TVA Nuclear Power Group, including Browns Ferry Nuclear Plant, Sequoyah Nuclear Plant, Watts Bar Nuclear Plant, and TVA's Nuclear Generation Development and Construction organization. This report is referenced in TVA's Updated Final Safety Analysis Reports (UFSAR) for each of TVA's operating nuclear power plants and must comply with the submittal frequency requirements of the UFSARs. Previous Organization Topical Reports have been submitted annually to ensure that the submittal requirements in accordance with 10 CFR 50.71, "Maintenance of records, making of reports," paragraph (e) are met for each operating plant.

TVA has reviewed the last UFSAR amendment submittal dates to NRC for each operating plant and determined that the above extension is in compliance with 10 CFR 50.71(e). The last UFSAR amendments for Browns Ferry Nuclear Plant, Sequoyah Nuclear Plant, and Watts Bar Nuclear Plant were provided to NRC by letters dated October 11, 2007 (Ref. 2), December 5, 2008 (Ref. 3) and September 23, 2008 (Ref. 4), respectively.

Accordingly, TVA will submit the latest revision TVA's Organization Topical Report (TVA-NPOD89-A) by September 14, 2009, instead of the originally planned submittal date of August 29, 2009.
