Mike -- I queried the folks here at ORNL, and some of them have received password information to log onto the Luminant Reading Room. I attempted to download the required Citrix software, and I believe that it installed correctly. However, when I try to access the Reading Room, I encounter an error message. At least two of the ORNL folks have encountered the same error, as explained below.

After we have logged in to the site, and then when we attempt to access the "Reading Room," we receive a dialog box that says "Connecting to CPNPP Reading Room." There is a progress bar in this box that shows the time left to complete the connection process. When this bar gets to about the one-half to three-quarters point, we receive an error dialog box entitled "CPNPP Reading Room ERROR" The text in this error box says "Cannot connect to the Citrix XenApp server. There is no Citrix SSL server configured on the specified address."

Do you want me to contact Don Woodlan directly about our problems at ORNL, or do you want us to work thru you at NRC to get the problems fixed?

For whatever it's worth, we have extremely restricted computer privileges here at ORNL, and it may be that the required software isn't loading properly. We may need to engage our internal IT support folks to permit us to install the software and/or gain access to the site.
