Here are some additional questions regarding the Feb 24-26 Environmental Review site audit:

1. Will the NRC and its contractors be taking any documents with them when they leave?
2. PPE - safety glasses, gloves, long-sleeved shirts, and sturdy shoes or boots will be required for the "brush" ecology specialized tour. CPNPP will provide safety glasses.
3. All we have planned for the "hydrology" specialized tour are the ground water monitoring wells. Please let us know if there is anything else the reviewers want to see on this tour.
4. Provenzano still appears in one meeting. I substituted Goodwin on our schedule.
5. The "other agencies" are only scheduled for Feb 24. Is this accurate to the best of your knowledge?
6. Please confirm that "Accidents" will not be a topic of discussion and that the five accident information needs will not be required.
7. There is no time on the schedule for the NRC and its contractors to meet in private and determine open items. However, we will assign a room to you so you may have such meetings if you so desire.
8. I understand that the Unit 1&2 radwaste facilities are no longer included in the "Fuel cycle/radwaste/HP/public health" specialized tour. Is this correct?
