Dear Colleen:

I want to thank you for providing us with the changes we asked for in the letter dated March 26, 2009. However, some additional and unrequested changes were made that we would like for you to consider changing back to the original condition (as listed in amendment #102) as we feel that the changes made in amendment #103 to those specific items below were made in error and do not necessarily fit with the current specific use of those isotopes listed in our license.

Specifically we request that the following changes be made to our license.

Amend

1. Under Column 6, please amend item “**S**” back to its original condition to read;
Column 6. - “*Americium-241*”

NOTE: This particular Americium-241 is used in a soil density gauge and not in medical applications.

2. Under Column 6, please amend line item “**EE**” to its original condition to read;
Column 6. - “*Californium-252*”

NOTE: We do not use Californium-252 in 10 CFR35.200 procedures.

Also there were a few occasions when a “**BOLD**” emphasis was used, which I understood may have been used in the past with other amendments to identify changes made since the last amendment, but in the cases listed below there were no changes actually made or requested yet they were still bolded, at least in the license amendment #103 copy that was provided to us.


