The purpose of this modification is to provide incremental funding in the amount of \$10,000.00 thereby increasing the total obligations from \$100,000.00 to \$110,000.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$110,000.00, of which \$105,337.00 represents the estimated reimbursable costs and the amount of \$4,663.00 represents the fixed fee."

All other terms and conditions of the subject task order remain unchanged including the task order ceiling of \$173,110.
