1. Decrease the ceiling of this task order by \$111,837.29, from \$721,861.03 to \$610,023.74.
2. Replace the existing price schedule with the attached revised price schedule, dated July 21, 2009, listing labor categories, hourly rates, and estimated labor hours, for a total estimated ceiling amount of \$610,023.74.
