Our company is extremely concerned about the proposed rule changes you sent out on August 5, 2009. Forcing each of our 165 customers to switch from a General License to a Specific License would cause dramatic cost increases due to additional training and annual fees. Believe me when I tell you that most of our customers simply cannot afford cost increases like these in today's economic environment.

In addition, the proposed modification of the Compatibility Categories is of major concern to our company. In our opinion, switching from Compatibility Category B to C and allowing states to have stricter rules than the federal ones helps no one. We currently distribute and perform service on isotope thickness gauges all over the country. What an administrative nightmare it would be to have the potential for different sets of rules and guidelines in each state!

Thank you for your reconsideration of these proposed changes.
