The purpose of this modification is to provide incremental funding in the amount of \$10,000.00 thereby increasing the total obligations from \$40,000.00 to \$50,000.00. Accordingly the Contract is modified as follows:

Refer to Section A.2 entitled "CONSIDERATION AND OBLIGATION - COST REIMBURSEMENT (JUN 1988) ALT 1 (JUN 1988)" paragraph b is deleted in its entirety and replaced with the following:

"(b) The amount presently obligated by the Government with respect to this contract is \$50,000.00"

All other terms and conditions remain unchanged including the contract value of \$130,558.28.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
