

The purpose of this modification is as follows:

- (1) To exercise Option Year 1 under the subject delivery order in accordance with FAR Clause 52.217-9 – Option to Extend the Term of the Contract. As a result, the ceiling amount of the subject delivery order is increased by \$1,007,368, from \$1,155,700 to \$2,163,068. By exercising the option year, the period of performance of the contract is extended through October 16, 2010.

Accordingly, the following section of the contract is hereby modified:

- (1) Section C.30 52.216-19 ORDER LIMITATIONS, Paragraph (b) is revised to read as follows:

- (b) Maximum order. The Contractor is not obligated to honor--
 - (1) Any order for a single item in excess of **\$2,163,068.00**;
 - (2) Any order for a combination of items in excess of \$2,861,468.00; or
 - (3) A series of orders from the same ordering office within 15 days that together call for quantities exceeding the limitation in paragraph (b)(1) or (2) of this section.

This modification does not obligate funds.

All other terms and conditions remain unchanged.
