The purpose of this modification is to exercise option year 2 increasing the contract ceiling by \$342,132.76 from \$654,140.90 to \$995,725.17. This also extends the period of performance through February 21, 2011. Accordingly the contract is revised as follows:

1. Paragraph (a) of Section B.4 entitled "Consideration and obligation – task orders (AUG 1989) Alternate 1 (JUN 1991)" is revised to read as follows:

(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$995,725.17. The Contracting Officer may place orders with the contractor during the contract period provided the aggregate amount of such orders does not exceed the MOL.

2. Section F.5 entitled: "Duration of Contract Period (MAR 1987) Alternate 4 (JUN 1988)" is revised to read as follows:

The ordering period for this contract shall commence on February 22, 2008 and will expire on February 21, 2011. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.).

All other terms and conditions remain the same.
