

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to provide incremental funding in the amount of \$55,000.00 thereby increasing the total obligations from \$250,000.00 to \$305,000.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$305,000.00, of which \$289,876.00 represents the estimated reimbursable costs and the amount of \$15,124.00 represents the fixed fee."

All other terms and conditions of the subject task order remain unchanged including the task order ceiling of \$334,188
