Due to the licensee's lack of response to the letter dated June 8, 2009, the option checked below will apply to the licensee's use of licensed material under an NRC license:

- You have reviewed your current license and have determined that you need to maintain both an NRC license and a State of New Jersey license. You therefore request that your existing NRC license be amended to remove authorization for use of material in the State of New Jersey and authorize work activities only in Non-Agreement States. In addition, you request that the NRC issue a new license for work activities only in the State of New Jersey. You understand that your new license will then be transferred to the State of New Jersey in conjunction with the effective date of the Agreement between the NRC and the State of New Jersey. You further understand that you will be assessed annual fees to maintain both the NRC and State of New Jersey licenses.
- The existing NRC license will be amended to authorize the use of material only in the State of New Jersey. This will be effective on the date the Agreement between the NRC and the State of New Jersey is signed. Upon the effective date of the Agreement between the NRC and the State of New Jersey, the licensee will be licensed by the State of New Jersey to conduct work at temporary job sites in the State and as such, must file a NRC Form 241 (reciprocity) prior to performing any work in NRC jurisdictions (Non-Agreement States) or in areas of Exclusive Federal Jurisdiction within an Agreement State.
