Reference: Robert G. Schaaf (NRC) to Dimitri Lutchenkov (UniStar Nuclear Energy), Calvert Cliffs Nuclear Power Plant Combined License Application Online Reference Portal, dated September 17, 2009.

UniStar Nuclear Energy (UNE) submits this response to the referenced NRC letter (Reference). The referenced letter provided conditions for the use of an online reference portal during the review of the Combined License Application (COLA) for Calvert Cliffs Nuclear Power Plant (CCNPP) Unit 3. The NRC has accepted the use of an online portal if certain control conditions are met throughout the duration of the CCNPP Unit 3 COLA review process. UNE was asked to confirm that these conditions will be maintained.

UNE confirms that the conditions below will be maintained throughout the duration of the CCNPP Unit 3 COLA review process. A description of the key elements of the UNE electronic reading room follows:

- The electronic reading room is password-protected, and passwords will be assigned to NRC staff and NRC contractors directly involved in the COLA review on a need-to-know basis;

- The electronic reading room disables any printing, saving or downloading functions to any location other than a printer or server controlled by UNE (note – UNE cannot prevent a user from printing a single page via screen print or from taking a picture of the computer screen with a camera beyond the login conditions-for-use concurrence);
- The electronic reading room is sufficiently secure to prevent staff from printing, saving or downloading any documents to any location other than a printer or server controlled by UNE (note – UNE cannot prevent a user from printing a single page via screen print or from taking a picture of the computer screen with a camera);
- Conditions of use of the online reference portal will be displayed on the log-in screen and will require concurrence by each user of the online reference portal upon entry;


UNE understands that NRC staff and NRC contractors given password access to the electronic reading room will also be informed of the conditions of use by the NRC project managers.

As noted above, UNE agrees to maintain these conditions throughout the duration of the CCNPP Unit 3 COLA review process, for as long as the electronic reading room needs to be available to NRC reviewers.

This letter does not include any new regulatory commitments and does not impact COLA content.
