The purpose of this modification is to provide incremental funding for the amount of \$222,000. The following paragraphs are modified (a) and (h) as follows:

1. Section B.5 Consideration and Obligation – Mixed Contract Types is modified as follows:

(a) The amount currently obligated by the Government with respect to CLINs 37 through 41 is \$178,034, of which the sum of \$167,215 represents the estimated reimbursable costs, and of which \$10,819 represents the fixed fee.

(h) The amount currently obligated by the Government for ergonomics and occupational safety and health (CLINs 35 and 36) is \$43,966, which changes the amount from \$65,100 to \$109,066.
