The purpose of this modification is to: (1) exercise Option Year 3 of the contract in accordance with Subsection C.6, Federal Acquisition Regulation Clause 52-217-9, entitled, "Option to Extend the Term of the Contract," and Subsection B.19, entitled, "Period of Performance," thereby extending the period of performance through August 24, 2010. As a result of this action, the ceiling amount of the contract is increased by 78,000.00 from 234,000.00 to \$312.000.00, (2) increase the obligation amount by \$30,000.00 from \$150,000.00 to \$180.000.00.

A. Subsection B.3, <u>Consideration and Obligation – Delivery Orders</u>, is deleted in its entirety and substituted with the following in lieu thereof:

"a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is **\$312,000.00**.

"b. The amount presently obligated with respect to this contract delivery order is **\$180,000.00**. The Contracting Officer may issue orders for work up to the amount presently obligated. The obligated amount shall, at no time, exceed the order ceiling as specified in paragraph "a" above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

C. Subsection B.5, <u>**Period of Performance**</u>, is deleted in its entirety and substituted with the following in lieu thereof:

"This contract shall commence on September 30, 2006, and will expire on August 24, 2010. There are no other option years to be exercised at this time."
