Subject: <u>Detroit Edison Company Submittal of Fermi Physical Security Plan, Revision 1</u>

Detroit Edison submitted Revision 0 of the Fermi Physical Security Plan in Reference 2 as part of the Fermi 3 Combined License Application (COLA). Since that submittal, industry guidance relating to format and content of security plans has been updated to reflect recent rulemaking, it is necessary to revise the Fermi Physical Security Plan. Revision 1 of the Fermi Physical Security Plan reflects the most recent revisions of NEI 03-12 and NEI 09-01, and replaces Revision 0 of the plan. Because of the extensive revisions in the industry guidance, Revision 1 of the Fermi Physical Security Plan is a complete rewrite of the plan and does not contain revision bars.

Revision 1 of the Fermi Physical Security Plan is intended for NRC review because it represents the most recent changes in regulations and guidance. However, to minimize COLA revisions, Detroit Edison intends to incorporate the revised Fermi Physical Security Plan into Part 8 of the COLA at a mutually agreeable time. That COLA revision would reflect this version of the plan, as modified if necessary, during the course of NRC review.
