SUBJECT: SUMMARY OF SEPTEMBER 24, 2009, MEETING WITH BEST®
THERATRONICS

Background

A public meeting was held on September 24, 2009, in Rockville, Maryland, between U.S. Nuclear Regulatory Commission (NRC) staff and Best® Theratronics, Ltd. (Best), as a follow-up to an NRC inspection (71-0943/2009-201), which occurred during August 10-14, 2009. The purpose of the meeting was to discuss details of quality assurance program implementation improvements made by Best. The NRC inspection team identified a number of programmatic concerns during the August inspection. One significant concern was identified regarding potential weld defects in Best's transport packages. The NRC recognizes that Best is in the process of addressing the potential weld defects through the normal implementation of their Quality Assurance (QA) Program. The NRC has an overall concern about Best's approach to full implementation of their QA Program, especially since this was the second meeting in four months to discuss Best's performance.

Discussion

The purpose of the meeting was for Best to present to NRC staff and management information regarding how it will improve the implementation of its QA Program. The meeting began with the SFST Division Director explaining that the inspection results describing Best's QA program implementation as marginally adequate was not acceptable to the NRC and should not be acceptable to Best. Additionally, NRC staff described the need for a philosophy shift and a top down commitment from Best to improve. The Best General Manager (GM) responded by ensuring the NRC that they are committed to improve from the top of the Best organization down through the Best staff. The Best GM also indicated that he was increasing his effort to assure the culture changes necessary at Best occurred. The NRC staff emphasized the need for Best to ensure full compliance with Part 71 requirements by strict procedural adherence and improved development of controlling procedures, drawings, and instructions. The NRC staff indicated that Best needs to improve the implementation of its QA Program to build our trust that Best will properly control its QA Program, Certificates of Compliance, and the safe shipment of radioactive materials.

Best described that they had already completed some of the easier corrective actions needed to address violations identified by the NRC during the inspection. Additional efforts are being undertaken by Best to contract with a quality assurance expert to provide further guidance, make additional quality improvements and provide required training to Best's staff. The SFST Division Director discussed the importance of an accurate and timely response to the inspection report and the associated findings and the continuing efforts by Best to eliminate recurrence of quality assurance issues. During the meeting, the NRC and Best made no regulatory commitments and no proprietary information was shared or discussed.
