- d. Since Jim Smith, M.S. will be the RSO at two facilities, please describe any adverse impact this will have on his duties as the RSO at your facility. If there will be no adverse impact, please state so, and why.
- e. Please describe how Jim Smith, M.S., will divide his time between both facilities Poplar Bluff Regional Medical Center, d/b/a Three Rivers Health Care, North, and Kennett HMA, Inc., d/b/a Twin Rivers Regional Medical Center, so that he will be able to adequately perform his duties as the Radiation Safety Officer
