Dear Mr. Null:

This letter is written as a follow up to your recent conversation with Dan Hoffman regarding the license amendment request dated August 24, 2009. Based on that conversation, the license application is revised as follows:

- 1. In Section 5, Table 5-1, Radioactive Materials to be Possessed, the last column of row (a) of the table is revised to include animal studies as a proposed use.
- 2. In Section 9, Facilities and Equipment, include the Stack and Building Data table, a copy of which is attached to this letter.
- 3. In Section 10.1, add the following paragraph at the end of the section titled "Radiation Safety Committee Audits":

"In addition to the above described audits, which shall be reviewed by the Radiation Safety Committee (RSC), a subcommittee of the RSC may be formed to review audit reports, including proposed findings and corrective actions to be taken to correct any identified deficiencies. Any deficiencies and proposed corrective actions that are considered significant by the RSC subcommittee shall be reviewed by the RSC. Examples of significant deficiencies include nonconformance with standard operating procedures relating to radiation safety or regulatory issues such as non-compliance with the NRC regulations in 10 CFR 20."


