

## APPENDIX G

## Information Needed for Transfer of Control

The following information is taken from NUREG-1556, Volume 15, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Material Licenses."

### Definitions

**Control:** Control of a license is in the hands of the person or persons who are empowered to decide when and how that license will be used. That control is to be found in the person or persons who, because of ownership or authority explicitly delegated by the owners, possess the power to determine corporate policy and thus the direction of the activities under the license.

**Transferee:** A transferee is an entity that proposes to purchase or otherwise gain control of an NRC-licensed operation.

**Transferor:** A transferor is an NRC licensee selling or otherwise giving up control of a licensed operation.

Licensees must provide full information and obtain NRC's *prior written consent* before transferring control of the license. Provide the following information concerning changes of control by the applicant (transferor and/or transferee, as appropriate). If any items are not applicable, so state.

1. Provide a complete description of the transaction (transfer of stocks or assets, or merger). Indicate whether the name has changed and include the new name. Include the name and telephone number of a licensee contact whom NRC may contact if more information is needed.

Advanced Healthcare Diagnostic Services, L.L.C. (Advanced Healthcare Diagnostic Services) is the legal entity that has maintained control of NRC license 24-32434-01. Advanced Health Care Management Services, L.L.C. (Advanced Health Care Management Services) owns 65% of Advanced Healthcare Diagnostic Services and has been the managing partner of Advanced Healthcare Diagnostic Services.

Advanced Healthcare Diagnostic Services wishes to transfer control of its NRC license and all assets to Advanced Health Care Management Services.

The partners of Advanced Healthcare Diagnostic Services have approved dissolution of the legal entity. With the NRC's approval, control of NRC license number 24-32434-01 will be transferred from Advanced Healthcare Diagnostic Services to Advanced Health Care Management Services. After transfer of control, the legal entity Advanced Healthcare Diagnostic Services, L.L.C. will be dissolved and the licensee name will change to Advanced Health Care Management Services, L.L.C.

2. Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel.

No changes will be made to personnel or duties.

3. Describe any changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.

The organization Advanced Healthcare Diagnostic Services, L.L.C. will be dissolved. Advanced Health Care Management Services owns 65% of Advanced Healthcare Diagnostic Services and has been the managing partner of Advanced Healthcare Diagnostic Services.

Advanced Health Care Management Services, L.L.C. will own 100% of the license once the transfer is approved.

No changes are being made to the location, facilities, equipment, or procedures related to the licensed program. The mailing address for Advanced Health Care Management Services is as follows:

4. Describe the status of the surveillance program (surveys, wipe tests, quality control) at the present time and the expected status at the time that control is to be transferred.

The surveillance program is currently in full compliance with 10 CFR Parts 20 and 35. The surveillance program will continue to be maintained in full compliance with 10 CFR Parts 20 and 35 subsequent to control being transferred to Advanced Health Care Management Services, L.L.C.

5. Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.

The transferee has been responsible for the management of the licensed program. The transferee will continue to maintain all records concerning the safe and effective decommissioning of the facility.

6. Confirm that the transferee will abide by all constraints, conditions, requirements, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.

The transferee will abide by all constraints, conditions, requirements, and commitment of the transferor. No changes are being made to the operations of the currently licensed program.
