**LICENSEE:**

The inspection was an examination of the activities conducted under your license as they relate to radiation safety and to compliance with the Nuclear Regulatory Commission (NRC) rules and regulations and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector. The inspection findings are as follows:

(Violations and Corrective Actions)

Condition 12 of NRC License No. 24-13737-01 named an individual as the Radiation Safety Officer (RSO). However, from December 16, 2008, to August 25, 2009, an individual other than the individual named in Condition 12 of the license served as the licensee's RSO.

As corrective action, the licensee committed to ensure that it promptly requests future license amendment requests to change the individual named as the RSO on the license to ensure that new RSOs are authorized on the license before they begin to serve as the RSO. The licensee also committed to ensure that, if its authorized RSO leaves the licensee's employ on short notice, it will promptly notify the NRC of the situation and promptly request a license amendment to authorize the new RSO on the license.

**Statement of Corrective Actions**

I hereby state that, within 30 days, the actions described by me to the inspector will be taken to correct the violations identified. This statement of corrective actions is made in accordance with the requirements of 10 CFR 2.201 (corrective steps already taken, corrective steps which will be taken, date when full compliance will be achieved). I understand that no further written response to NRC will be required, unless specifically requested.
