Halliburton Energy Services, Inc. is applying for an amendment to extend the validity date for **License CBP78-1** for the export and import of Category 2 Americium-241, Americium-241/Be sources for shipment that are in the excess of the 0.6 terabequerels threshold and Cesium-137 sources for shipments that are in the excess of the 1.0 terabequerels threshold. These materials will be used to calibrate down hole well logging equipment for the completion of an oil or gas well. These items are subject to the export licensing jurisdiction of the U. S.
