As you are no doubt aware, under the provisions of the Energy Policy Act of 2005 (EPAAct), sometime between now and August 9, 2009, the Nuclear Regulatory Commission (NRC) will be assuming regulatory authority over all Radioactive Material some of which was regulated by the Missouri Radiation Control Program. As of that [as yet to be finalized] date, authority for licensing and enforcement actions in regard to all non-exempt quantities of Radioactive Material will be transferred to the NRC. Until that date, the MRCP's authority will continue. At some point in the future you will be contacted by the NRC to begin the process of applying for a new federal license for the continued possession and usage of your radioactive material (or, if applicable, amending your current NRC license).

To begin to prepare for and aid with the transition process, we have changed the expiration date of all current RAM registrations to August 10, 2009, based on the facility information currently in our database. Your facility last registered with our office on: 06/18/2007

Enclosed is the registration we currently have on file for your facility, which will now be valid until the NRC assumes regulatory authority. You will only need to contact our office if conditions change or new RAM is added, or possession amounts need to be changed. In that case contact our office for an amendment to the registration, as you have in the past. If you no longer use or possess naturally occurring or accelerator produced radioactive material, please advise us by return mail or call (573) 751-6083. If you have additional questions, please do not hesitate to contact us and ask to speak with Tracy Roark, Gary Franklin (Medical Sources) or Chuck Arnold (non-Medical Sources).
