B.2 BILLING RATE REQUIREMENTS

All LEC regulated cost shall be billed in accordance with FAR 52.232-6, "Payment under Communication Service Contracts with Common Carrier," and shall be billed in accordance with the Public Utility Commission's rate plan. It is the sole responsibility of the Contractor to submit any rate changes to the NRC Contracting Officer for incorporation into the contract.

B.3 CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUN 1988)

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$32,440.32. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

(b) The amount presently obligated with respect to this contract is \$5,000.00. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

B.4 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987)

This contract shall commence on November 5, 2009 and will expire on November 4, 2011. The term of this contract may be extended at the option of the Government for an additional THREE 1-YEAR PERIODS.

B.5 STATEMENT OF WORK

PROJECT TITLE: Region I Telecommunication Services

1. BACKGROUND

In accordance with the mission of U.S. Nuclear Regulatory Commission, Region I office in King of Prussia, Pennsylvania, the NRC requires telecommunication services to support data, voice and video connectivity. This connectivity is currently provided by Verizon through PBX interconnections, digital circuits with or without modems (3002), 2 T1/PRI circuits (ESF/B8ZS), dedicated pair (48F), Integrated Services Digital Network (ISDN), Asynchronous Digital Subscriber Line (aDSL), and Dedicated Data Service (DDS) between 9.6 and 56Kbs.

The 2 T1/PRI circuits are configured as ESF/B8ZS framing encoding with NI2 D-Channel Protocol. There is a dedicated D-Channel for each T1/PRI. Additionally, all 46 B-Channels are in one trunk group with 2-way DID service and a received DID digital length equal to 4.

The current telephone numbers for the Region I office are 610-337-5000 thru 5399 and 6900 thru 6999. These are brought to the PBX via 2 T1 carrier systems of 24 channels each, (total 48 trunks). In addition, there are 8 backup circuits brought to the Region I office on wire with the following telephone numbers: 610-337-1070, 1071, 1073, 1074, 1075, 1078, 1079, and 1080.

2. OBJECTIVE

The objective of this effort is to outline NRC requirements for the contractor to provide telecommunication services to support data, voice and video connectivity.

3. SCOPE

The Contractor shall provide telecommunication services, including emergency and backup service, to the demarcation point of the Region I office location at 475 Allendale Road, King of Prussia, Pennsylvania. The services include, but are not limited to, providing PBX interconnections to a central office for dial tone and switching, 2 T1/PRI ESF/B8ZS framing encoding circuits with a dedicated NI2 D-Channel Protocol for each T1/PRI, and direct cable service of 8 circuits wired directly to the PBX for normal use and emergency backup utilization.

4. COMPLIANCE REQUIREMENTS

The Contractor shall provide services in accordance with the rates, terms and conditions set forth in the applicable Tariffs of the Contractor, as filed with, and approved by, the Pennsylvania Public Utility Commission and/or the Federal Communications Commission.

Contractor services shall be in conformance with all applicable accepted Industry and Federal standards, such as those standards maintained or established by the Electronic Industries Association, Telecommunications Industries Association, Institute of Electrical and Electronics Engineers, Rural Electrification Administration, and Federal Communications Commission. In addition, Contractor work shall meet the standards established in the National Electric Code, Local Building Code, National Fire Code, and State and Local Fire Codes.

5. TECHNICAL REQUIREMENTS

TASK 1 TELECOMMUNICATION SERVICES

The Contractor shall provide telecommunications services, including emergency and backup service, to the demarcation point of the Region I office location at 475 Allendale Road, King of Prussia, Pennsylvania. These services shall: support voice, data, and video connectivity at various speeds; interface with the Nortel CS1000-SG PBX system; include unblocked access and interface into the Federal Telecommunications System (FTS) 2001 and Network environment for long distance service, and interface with commercial long distance carriers. The Contractor shall provide number portability for all phone numbers currently in use at the Region I location.

T1/PRI Circuits:

- a. 2 – T1/PRI
- b. Framing/Encoding: ESF/B8Zs
- c. D-Channel Protocol: NI2 (dedicated D-Channel for each T1/PRI)

- d. All 46 B-Channels shall be in one trunk group
- e. 2-Way DID service
- f. Received DID Digits Length = 4

Optional Items: Do to technological changes or agency requirements the NRC may require the services below, items g through o. These items are not being procured at this time. Should the NRC require one or all of these items a formalized bilateral modification will be executed by the NRC Contracting Officer.

- g. Integrated Services Digital Network (ISDN)
- h. FDDI Network Service (FNS)
- i. Asynchronous Digital Subscriber Line (aDSL)
- j. Measured Business (1MBs) Lines
- k. 3002, 48F Circuits
- l. Digital Data Service (DDS)
- m. High Capacity Digital Service (T1)
- n. Switched Multi megabit Data Service (SMDS)
- o. Frame Relay

TASK 2 PLACING SERVICE CALLS

Within fifteen working days of contract award, the Contractor shall provide the NRC PO with procedures to be used to obtain services during and outside of the Region I normal business hours and in emergency situations. The procedures shall include a primary and alternate telephone number and name(s) of individuals to contact. For the Region I office, normal business hours are 7:30 a.m. to 4:15 p.m. Eastern Standard Time.

TASK 3 EMERGENCY AND NON-EMERGENCY OUTAGE

The Contractor shall provide 24-hour emergency maintenance service for equipment and to support connectivity, 7 days a week, 365 days a year. Emergency maintenance will be requested by verbal and/or written request from the NRC Project Officer (PO) or Contracting Officer (CO). The Contractor shall provide, at no charge, for all contractor-furnished services and equipment, trouble and/or fault isolation and diagnostic testing in accordance with industry standards and shall initiate corrective action after notifying the PO.

(A) EMERGENCY (MAJOR OUTAGE) MAINTENANCE

The NRC may require work to be performed on an emergency basis. Work to be performed on an emergency basis shall require a one-hour response time by telephone from the time the NRC PO, CO, or designee initiates the call. If on-site service is required, the contractor shall dispatch a technician to arrive on-site within 4 hours on the same day.

(B) NON-EMERGENCY (ROUTINE) MAINTENANCE

The NRC may require work to be performed on a routine basis. Work to be performed on a routine basis shall require a four-hour response time from the time the NRC PO, CO, or designee initiates the call. If on-site service is required, the contractor shall dispatch a technician to arrive on-site by the next business day.

TASK 4 RECOMMENDATIONS

The Contractor shall analyze telecommunications support provided and make recommendations for upgrade, change, or improvement to the NRC PO.

TASK 5 INVENTORY

The Contractor shall take an initial inventory of existing services within the first 30-days, after the contract start date to be validated and agreed upon by both the vendor and the Government.

TASK 6 SERVICE ISSUES

When it is determined that NRC equipment is at fault for a specific problem, the Contractor's technician shall note on the work order for the specific problem, the actions taken to determine the source of the fault, and shall notify the NRC PO immediately. If, in performing the repair or follow-up, it is determined that the specific problem was actually related to Contractor-provided equipment or services, any or all charges to NRC for correction of the fault shall be credited on the subsequent monthly invoice.

The Contractor may be required to coordinate with other NRC service providers in conjunction with the NRC PO in order to correct problems and restore communications.

The Contractor shall not make modifications, alterations, or changes to any existing NRC telecommunications configuration unless authorized in writing by the NRC PO or CO.

The Contractor shall not disable, bypass or otherwise render inoperative, any safety device within the NRC telecommunications configuration.

The Contractor shall report to the NRC PO any situation that could cause system failure or the degradation of telecommunications services and recommend possible corrective action.

6. PERSONNEL QUALIFICATIONS

All Contractor technical personnel providing services under this contract shall have the requisite qualifications and experience to perform the required tasks. These qualifications and experience shall be in the following areas: performing installation and maintenance of specialized equipment such as fiber optics; cable design, fabrication, installation, and removal; fault isolation techniques, trouble-shooting, diagnostic equipment utilization, initiation of corrective action, and ability to distinguish and interpret color codes and identify circuit/line termination points.

All personnel performing work on this task order must present proper credentials (photo identification) to the Receptionist prior to gaining access to the facility. In addition, all personnel providing work on this task order shall be escorted at all times while on NRC premises.

7. SERVICE REQUEST

The NRC PO, CO, or designee will initiate a service request to the Contractor in writing. Service requests shall be confirmed in writing within five (5) working days. The documentation

must have the signature of the NRC PO, CO, or designee as approval for the Contractor to complete the work. The document shall contain the following information:

- Type of request
- Location and type of service required
- Name and telephone number of the NRC points of contact having the ability to provide additional information and/or facility access as required.

The NRC PO, CO, or designee will be the only individuals authorized to initiate service request. The NRC will not be held liable for any cost incurred by the Contractor for performance of any work in response to a service request call initiated by any unauthorized individual.

8. PERFORMANCE REQUIREMENTS SUMMARY

Contractor performance is considered acceptable according to the criteria delineated in the table below. Failure to meet the performance standards will result in applicable invoice deduction amount and may have a negative impact on the Government's decision to exercise options for future periods of performance.

9. ADDITIONAL CONTRACTOR RESPONSIBILITIES

The Contractor shall also be responsible for:

- Ensuring all areas in which work occurs are left broom-clean and free of debris.

- Removal and replacement of ceiling tiles associated with maintenance or installation of telecommunications services.
- The Contractor shall repair and return to original condition, at no cost to the government, all surfaces (to include, but not limited to floors, walls, ceilings, doors and windows) which are damaged or marred by Contractor personnel.

The Contractor shall ensure that all moves, adds, or changes to the Contractor-furnished and installed telecommunications services are approved by the CO, or PO when designated by the CO. The NRC will not be responsible for any changes made to Contractor-furnished and/or installed services that are not approved by the PO/CO.

10. NRC RESPONSIBILITIES

The NRC will:

- Provide security for the telecommunications distribution system equipment room and wire closets.
- Provide the Contractor access to buildings and offices requiring telecommunications services.
- Provide the Contractor with information for any Government furnished equipment requiring interconnection with the Contractor's telecommunications equipment.

SECTION C - CONTRACT CLAUSES**ADDENDUM TO FAR 52.212-4 CONTRACT TERMS AND CONDITIONS--COMMERCIAL ITEMS**

Clauses that are incorporated by reference (by Citation Number, Title, and Date), have the same force and effect as if they were given in full text. Upon request, the Contracting Officer will make their full text available.

The following clauses are incorporated into 52.212-4 as an addendum to this contract:

C.1 52.216-18 ORDERING (OCT 1995)

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from day of award through the effective contract period.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) If mailed, a delivery order or task order is considered "issued" when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

C.2 52.216-21 REQUIREMENTS (OCT 1995)

(a) This is a requirements contract for the supplies or services specified, and effective for the period stated, in the Schedule. The quantities of supplies or services specified in the Schedule are estimates only and are not purchased by this contract. Except as this contract may otherwise provide, if the Government's requirements do not result in orders in the quantities described as "estimated" or "maximum" in the Schedule, that fact shall not constitute the basis for an equitable price adjustment.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. Subject to any limitations in the Order Limitations clause or elsewhere in this contract, the Contractor shall furnish to the Government all supplies or services specified in the Schedule and called for by orders issued in accordance with the Ordering clause. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(c) Except as this contract otherwise provides, the Government shall order from the Contractor all the supplies or services specified in the Schedule that are required to be purchased by the Government activity or activities specified in the Schedule.

(d) The Government is not required to purchase from the Contractor requirements in excess of any limit on total orders under this contract.

(e) If the Government urgently requires delivery of any quantity of an item before the earliest date that delivery may be specified under this contract, and if the Contractor will not accept an order providing for the accelerated delivery, the Government may acquire the urgently required goods or services from another source.

(f) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were

completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after 3 months from contract expiration.

C.3 52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 60 days.

C.4 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 2000)

(a) The Government may extend the term of this contract by written notice to the Contractor within 60 days; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 30 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(b) Performance of the work under this contract is subject to the technical direction of the NRC project officer. The term "technical direction" is defined to include the following:

(1) Technical direction to the contractor which shifts work emphasis between areas of work or tasks, authorizes travel which was unanticipated in the Schedule (i.e., travel not contemplated in the Statement of Work (SOW) or changes to specific travel identified in the SOW), fills in details, or otherwise serves to accomplish the contractual SOW.

(2) Provide advice and guidance to the contractor in the preparation of drawings, specifications, or technical portions of the work description.

(3) Review and, where required by the contract, approval of technical reports, drawings, specifications, and technical information to be delivered by the contractor to the Government under the contract.

(c) Technical direction must be within the general statement of work stated in the contract. The project officer does not have the authority to and may not issue any technical direction which:

(1) Constitutes an assignment of work outside the general scope of the contract.

(5) Terminates the contract, settles any claim or dispute arising under the contract, or issues any unilateral directive whatever.

(d) All technical directions must be issued in writing by the project officer or must be confirmed by the project officer in writing within ten (10) working days after verbal issuance. A copy of the written direction must be furnished to the contracting officer. A copy of NRC Form 445, Request for Approval of Official Foreign Travel, which has received final approval from the NRC must be furnished to the contracting officer.

(e) The contractor shall proceed promptly with the performance of technical directions duly issued by the project officer in the manner prescribed by this clause and within the project officer's authority under the provisions of this clause.

Preparation and Itemization of the Voucher/Invoice: The voucher/invoice shall be prepared in ink or by typewriter (without strike-overs). Corrections or erasures must be initialed. To be considered a proper voucher/invoice, all of the following elements must be included:

1. Contractor's Data Universal Number (DUNS) or DUNS+4 number that identifies the contractor's name and address. The DUNS+4 number is the DUNS number plus a 4-character suffix that may be assigned at the discretion of the contractor to identify alternative Electronic Funds Transfer (EFT) accounts for the same parent concern.
2. Contract number.
3. Sequential voucher/invoice number.
4. Date of voucher/invoice.
5. Payee's name and address. Show the name of the Payee as it appears in the contract and its correct address. If the Payee assigns the proceeds of this contract as provided for in the assignment of claims terms of this contract, the Payee shall require as a condition of any such assignment, that the assignee shall register separately in the Central Contractor Registration (CCR) database at <http://www.ccr.gov> and shall be paid by EFT in accordance with the terms of this contract. See Federal Acquisition Regulation 52.232-33(g) Payment by Electronic Funds Transfer - Central Contractor Registration (October 2003).
6. A description of articles or services, quantity, unit price, and total amount.
7. For contractor acquired property, list each item with an initial acquisition cost of \$50,000 or more and provide: (1) an item description, (2) manufacturer, (3) model number, (4) serial number, (5) acquisition cost, (6) date of purchase, and (7) a copy of the purchasing document.
8. Weight and zone of shipment, if shipped by parcel post.
9. Charges for freight or express shipments. Attach prepaid bill if shipped by freight or express.
10. Instructions to consignee to notify the Contracting Officer of receipt of shipment.

11. For Indefinite Delivery contracts or contracts under which progress payments are authorized, the final voucher/invoice shall be marked "FINAL VOUCHER" OR "FINAL INVOICE."

Currency: Billings may be expressed in the currency normally used by the contractor in maintaining his accounting records and payments will be made in that currency. However, the U.S. dollar equivalent for all vouchers/invoices paid under the contract may not exceed the total U.S. dollars authorized in the contract.

Supersession: These instructions supersede any previous billing instructions.
