SUMMARY

We have reviewed your amendment request dated June 02, 2009, and find that we need additional information as follows:

1. Confirm that you want to remove 444 W. Baldwin, Alpena, MI from your license.
2. Per your submittal, on May 30, 2009, you have transferred and added a new storage location for your portable gauges at 3205 US-23 South, Alpena, MI. 10 CFR 30.34(c) requires, in part, that each person licensed by the Commission pursuant to the regulations in this part and parts 31 through 36 and 39 shall confine his possession and use of the byproduct material to the locations and purposes authorized in the license. At this time, no response is required, however, this maybe subject to future inspection.

We will be unable to continue processing your request until we receive this information. 
