Enclosed is Amendment No. 18 to your NRC Material License No. 21-26391-01 in accordance with your request. Please review the enclosed document carefully and be sure that you understand all conditions.

**In correspondence dated July 20, 2009, you indicated that you wished to release the location at 23822 Ford Road, Dearborn Heights, Michigan for unrestricted use.**

**The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from your former location of use and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this location and it is suitable for unrestricted use.**

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 CFR 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
