We have a problem with the enrichment as listed on the export license. It states 93.15% max and the material is 93.177%. Your request was for greater than 93%. Also, if you calculate 50 grams by 93.177 you get 46.5885 grams of U-235. You listed 46.58 on the export license. I would recommend contacting the NRC directly and requesting that the export license be amended to increase the enrichment to 93.20 max and the U-235 to 46.6. As you know there is plus or minus for accuracy on the weights and the enrichment so the customer could get a slightly higher enrichment analysis. You need a little contingency in there. On such as change I have seen the export license amended in as little as 2 days by contacting the NRC directly. Please let me know if this is possible.
