14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to provide incremental funding in the amount of \$100,000; thereby increasing the obligated amount from \$86,810 to \$186,810. Accordingly, the following is hereby modified:

Section B.2, Consideration and Obligation - Labor Hour Contract, paragraphs (b) and (c) are revised as follows:

"(b) The amount currently obligated by the Government with respect to this contract is \$186,810. The contractor shall not exceed this obligated amount at any time."

"(c) It is estimated that the amount currently allotted will cover performance through twenty-three (23) months from award date."

All other terms and conditions remain unchanged, including the ceiling amount of \$295,776.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
