

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to increase the obligated amount by \$150,000 from \$743,958 to \$893,958. Accordingly, paragraph (d) of section B.3 entitled: "Consideration and Obligation Cost Plus Fixed Fee (JUN 1988) Alternate I (JUN 1991) is revised to read as follows:
"(c) The amount currently obligated by the government with respect to this contract is \$893,958."
