COGEMA Mining; Inc. (COGEMA) has submitted an Application for Change of Control to the Nuclear Regulatory Commission (NRC) for its Source Material License SUA-1341 at the Irigaray and Christensen Ranch uranium *in-situ* recovery facilities in Johnson and Campbell Counties, Wyoming. COGEMA has requested that NRC consent to the change in control. The Irigaray and Christensen Ranch facilities are located within the Powder River Basin of Wyoming, approximately 5 miles west of the Pumpkin Buttes. The notice of change of control was accepted for technical review by NRC staff on October 15, 2009. By the end of next week (November 6, 2009), a Notice of the Change in Control and Ownership Information for the Source Materials License SUA-1341, COGEMA Mining, Inc., Christensen and Irigaray Ranch Facilities, Johnson and Campbell Counties, WY, and Opportunity to Request a Hearing will be published in the *Federal Register*. The NRC is notifying you of this request as you may have an interest in this action.
