Submittal of ABWR Topical Report Supporting STP 3 & 4 Fuel Amendment

On January 30, 2009 STPNOC met with the NRC staff to discuss the topical reports planned for submittal to the NRC to support a future fuel license amendment for STP 3 & 4. STPNOC intends to submit a license amendment in the mid-2013 time frame to adopt a more modern fuel assembly design. This is the second of a series of topical reports that is being submitted to support that license amendment.
