The purpose of this modification is to provide funding in the amount of \$128,296.88; thereby increasing the obligated amount from \$50,000 to \$178,296.88, fully funding the delivery order. Accordingly, paragraphs (b) and (c) of Section A.2 entitled "Consideration and Obligation - Labor Hour" are revised to read as follows:
