

The purpose of this modification is to provide incremental funding in the amount of \$60,000.00 thereby increasing the total obligations from \$50,000.00 to \$110,000.00. Accordingly the Contract is modified as follows:
Refer to Section A.2 entitled "CONSIDERATION AND OBLIGATION - COST REIMBURSEMENT (JUN 1988) ALT 1 (JUN 1988)" paragraph b is deleted in its entirety and replaced with the following:
"(b) The amount presently obligated by the Government with respect to this contract is \$110,000.00"
