SUBJECT: SUMMARY OF OCTOBER 22, 2009, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On October 22, 2009, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting, via teleconferencing, with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs. The staff requested that industry stakeholders submit any remaining Probabilistic Risk Assessment related FAQs to the FAQ process.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure. Additionally, the staff noted that pre-submittal meetings are available to non-pilot licensees regarding specific technical issues.

Participants agreed that the next FAQ meeting would take place on November 19, 2009, at NRC headquarters.
