Dear Mr. Jones:

By letter dated January 15, 2008, we informed you of the impending Agreement between the U.S. Nuclear Regulatory Commission (NRC) and the Commonwealth of Pennsylvania, whereby, the NRC would relinquish regulatory authority for certain licenses of byproduct, source, and special nuclear material. Due to an error by the NRC, your license, NRC License No. 20-30024-03, was not turned over to the Commonwealth of Pennsylvania at the time of the Agreement. The error was discovered while processing your new license application dated October 22, 2009.

To correct the error you will find enclosed with this letter an amended NRC license and a new license. The amended license, NRC License No. 20-30024-03, has removed the Bethlehem, Pennsylvania location and added the Catano, Puerto Rico location. The new license, NRC License No. 20-30024-05, is for the Bethlehem, Pennsylvania location and will be turned over to the Commonwealth of Pennsylvania.

Please review the documents carefully and be sure that you understand and fully implement all the conditions incorporated into the licenses. If there are any errors or questions on the NRC license, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers. Errors or questions on the license authorizing licensed activities in the Commonwealth should be directed to John Chipppo at the Pennsylvania Department of Environmental Protection, Bureau of Radiation Protection at (717) 787-2208.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
