**NRC REGULATORY ISSUE SUMMARY 2009-15
NATIONAL SOURCE TRACKING SYSTEM
ANNUAL INVENTORY RECONCILIATION**

ADDRESSEES

All licensees possessing Category 1 or Category 2 quantities of radioactive materials.
All Radiation Control Program Directors and State Liaison Officers.

INTENT

The U.S. Nuclear Regulatory Commission (NRC) is issuing this Regulatory Issue Summary (RIS) to inform addressees of the process to complete the National Source Tracking System (NSTS) Annual Inventory Reconciliation and to inform licensees that the primary communication tool for NSTS updates will be the NSTS Blog (<http://www.nrc.gov/security/byproduct/nsts/blog.html>) and the NSTS website (<http://www.nrc.gov/security/byproduct/nsts.html>). No specific action nor written response is required. NRC is providing this RIS to the Agreement States for their information and for distribution to their licensees as appropriate.

BACKGROUND

The NSTS was deployed in December of 2008, and was available for use in January of 2009.

Licensees possessing Category 1 and Category 2 radioactive sources were required to report their initial source inventories to NSTS and to begin reporting source transactions by January 31, 2009. Transactions include manufacture of a new source, transfer, receipt, disassembly, and disposal.

In addition, the regulations for NSTS require licensees to annually reconcile their NSTS inventories in the month of January (10 CFR 20.2207(g) or Agreement State equivalent).

SUMMARY OF ISSUE

January 2010 marks the first Annual Inventory Reconciliation. Licensees can complete this process either through the online NSTS or manually via fax, mail, or email. Part of the reconciliation process will include resolving any discrepancies between the information in the NSTS and the actual inventory. The reconciliation is to occur during the month of January, and by January 31, 2010, each licensee must submit confirmation to the NSTS that the data in the system is correct. For the licensees with online access to NSTS, the Annual Inventory

Reconciliation feature will be deployed with the December system update. The NRC encourages licensees to complete the Annual Inventory Reconciliation online. Completing the Annual Inventory Reconciliation online is quick and simple. The process will consist of:

- Logging into the system
- Viewing the inventory
- Reconciling the source information
- Submitting the confirmation of accuracy

For those users without online access, the process will consist of:

- Receiving a copy of the inventory via email or mail
- Viewing the inventory
- Reconciling the source information
- Submitting the confirmation of accuracy, via fax, email, or mail

The NSTS Help Desk will send each licensee **without online access** a copy of their inventory for reconciliation purpose. This inventory report will be distributed to the attention of the Primary Contact on the license record in NSTS. It will be emailed to the email address on the license record in NSTS. If there is no email address provided, the report will be mailed to the mailing address on the license record in NSTS. If you do not receive your inventory report by **January 8, 2010**, please contact the NSTS Help Desk (NSTS.Help@nrc.gov or 1-877-671-6787).

Licensees are reminded that information submitted to the Commission (including reports of transactions involving nationally tracked sources and the confirmation required as part of the licensee's annual reconciliation of its NSTS inventory) must be complete and accurate in all material respects. This includes reports and information submitted electronically, by facsimile, by mail, on-line via the National Source Tracking System, and by phone to the NSTS Help Desk or NRC staff. In addition, §20.2207 (g) requires licensees to correct errors in previously filed reports and to report missed transactions within 5 business days of the discovery of the error or missed transaction. This applies to errors or missed transactions identified by the licensee, or brought to the attention of the licensee by another entity such as a licensee involved in the transaction, the NSTS Help Desk, the NRC staff, or staff of an Agreement State.

Since January 2010 is the first time the Annual Inventory Reconciliation will be completed, the NRC staff developed a User Guide which provides step-by-step instructions for completing the Annual Inventory Reconciliation. This User Guide is available on the website: <http://www.nrc.gov/security/byproduct/nsts.html>. A paper copy of the User Guide is available by request through the NSTS Help Desk (1-877-671-6787).

The NSTS Blog (<http://www.nrc.gov/security/byproduct/nsts/blog.html>) is the primary method of NRC communications with the NSTS licensees. There is a subscription capability available on the site to receive email notifications when there is a new Blog posting. To ensure you do not miss important NSTS information, you may subscribe to the Blog updates. The NRC is using the Blog to communicate information such as website updates, notification of upcoming events such as NSTS training or industry meetings, and information on using NSTS online.

BACKFIT DISCUSSION

This RIS requires no action or written response and the backfit rule (10 CFR 50.109, 70.76, 72.62, or 76.76) does not apply. Consequently, the NRC staff did not perform a backfit rule analysis.
