To whom it may concern:

Please find enclosed NRC Form 314, Certificate of Disposition of Materials. We are in the process of closing our nuclear medicine laboratory. As you can see, we have sent our calibration sealed sources to Pharmalogic, Inc.(our local radiopharmacy) for disposal in their waste system.

We currently have no radioactive material on-site. Surveys of our department, performed today, November 17, 2009 show no level of radioactivity above background(0.02 mR/hr) and no removable contamination in excess of 200 d/min. Areas surveyed included: dose receipt and preparation areas, injection and use areas, disposal areas, bathrooms, and public spaces connected thereto.

We will be selling off all equipment related to our nuclear medicine operations, and will be reusing that area for future office space expansion.
