SUNSI REVIEW COMPLETE

1. On page F-1, DURATION OF CONTRACT PERIOD (MAR 1987) modify to read as follows:

"The period of performance for this contract shall commence on December 1, 2004 and will expire on March 31, 2010. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18-Ordering). The term of this contract may be extended at the option of the Government for additional two-months.

- 2. On page 8-1, SCHEDULE OF ESTIMATED COSTS AND PRICES, the pricing outlined in Option Year 4 remains in effect during the extension from December 1, 2009 through March 31, 2010 for the following line items (CLINs 38, 39, 40, 43, 44, and 45):
  - Agency-wide Ergonomics,
  - · Agency-wide Occupational Safety and Health Program,
  - Automatic External Defibrillator (AED) Program,
  - · Regional Health Est. Costs,
  - Est. Cost Regional Fitness Centers, and
  - Resident Fitness Services

The Contractor is authorized to incorporate a combined 3.8% increase for costs incurred for the Agency-Wide Employee Wellness Program, (CLIN 37) and 3.7% for the Employee Fitness Program, (CLINs 41 and 42,). The total estimated dollar amount for all CLINS during the extension period is \$483,425.
