14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification number 016 is to extend the period of performance for four months from 11/30/2009 to 3/31/2010 and to include a option to extend for an additional two months. The Price Schedule is also revised to incorporate a 3.8% and 3.7% increase for inflation to cover services rendered for the Health Unit and Fitness during the extension period of December 1, 2009 through March 31, 2010.

This modification is revised as described on page 2.

1. On page F-1, DURATION OF CONTRACT PERIOD (MAR 1987) modify to read as follows:

"The period of performance for this contract shall commence on December 1, 2004 and will expire on March 31, 2010. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18-Ordering). The term of this contract may be extended at the option of the Government for additional two-months.

2. On page 8-1, SCHEDULE OF ESTIMATED COSTS AND PRICES, the pricing outlined in Option Year 4 remains in effect during the extension from December 1, 2009 through March 31, 2010 for the following line items (CLINs 38, 39, 40, 43, 44, and 45):

- Agency-wide Ergonomics,
- Agency-wide Occupational Safety and Health Program,
- Automatic External Defibrillator (AED) Program,
- Regional Health Est. Costs,
- Est. Cost Regional Fitness Centers, and
- Resident Fitness Services

The Contractor is authorized to incorporate a combined 3.8% increase for costs incurred for the Agency-Wide Employee Wellness Program, (CLIN 37) and 3.7% for the Employee Fitness Program, (CLINs 41 and 42,). The total estimated dollar amount for all CLINS during the extension period is \$483,425.
