Milestone Summary (10/21/09 to 11/18/09)

Met with MDE and USACE to discuss the Phase II non-tidal wetland mitigation plan 10/23/09.

- Removed Camp Conoy Bald Eagles nest 10/26/09. Completed Bald Eagle habitat enhancement work 11/3/09.
- Submitted Calvert County Grading Permit application 11/10/09.
- Met with SHA to discuss break in access control along Route 2/4 to allow for the proposed new intersection 11/16/09.



Ongoing Work

- USACE/MDE review of joint permit application; preparation of the Phase II mitigation plan. Phase II Concept Plan to be submitted in November.

- CPCN Air permit modification request to be submitted by the end of November 2009. When is Nec going to get this information
- Detailed planning of Camp Conoy demolition work. Demolition activity delayed until Summer 2010.



Anticipated Permit Sequence

- CPCN Final Order issued June 26, 2009
- Revised FCP approved by DNR; approval of conservation easements. expected by Q1 2010
- CAC off-site tree mitigation plan approved by CAC expected Q1 2010
- Cultural resources MOA with USACE/MHT expected November 2009
 - Implement MOA in non-wetland areas
- Traffic mitigation MOA w/SHA expected December 2009
- Calvert County grading permit approved expected December 2009
- DEIS issued by NRC for comment UniStar target date: Q1 2010
- USACE/MDE comment period Q1 2010
- MDE wetland permit/CZMA/401 expected Q3 2010
- FEIS issued by NRC UniStar target date: September 2010
- USACE (tidal, non-tidal) permit expected October 2010
- COL expected 2012.
