1) This modification increases the ceiling under Task Order #3 by \$22,331.21 from \$160,319.02 to \$182,650.23. On page 2 of the Task Order Award, under CONSIDERATION AND OBLIGATION(a), the first sentence is deleted in its entirety and replaced with the following:
"The total estimated cost the Government for full performance under this Task Order is \$182,650.23".

2) This modification adds FY10 funds in the amount of \$22,331.23 increasing the obligated amount from \$160,319.00 to \$182,650.23. On page 2 of the Task Order Award, under CONSIDERATION AND OBLIGATION(b), the first sentence is deleted in its entirety and replaced with the following:
"The amount obligated by the Government with respect to this Task Order is \$182,650.23".
