Under Section A.2, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), Paragraph (b), Sentence 1, is deleted in its entirety and replaced with the following:

“(b) The amount presently obligated with respect to this contract is \$579,000.00.”

All other terms and conditions of this delivery order remain the same, including the ceiling amount of \$800,000.00.
