Dear Meghan,

Attached, please find the monthly summary of marine turtle removals for December 2007. In December, we captured four (4) <u>Caretta caretta</u> and twelve (12) <u>Chelonia mydas</u> in the intake canal of the St. Lucie power plant on South Hutchinson Island. The temporary, primary barrier net is now in place and effectively containing all turtles in the canal to the east of that location. All turtles captured in December were released back to the ocean on the day of capture. Tag numbers and morphmetric data for all turtles are attached. Beginning in January we will quantify the number and severity of scrapes incurred by sea turtles entrained through the intake pipes. We will then be able to compare these data to previous year's data to determine what impact cleaning of the pipes has on reducing sea turtle injuries.
