REMARKS: IMC 0613 (Documenting 10 CFR Part 52 Construction Inspections) has been revised to incorporate the construction inspection screening process, inspection reporting guidance, and additional guidance in the new Appendices C through G.

IMC 2600 (Fuel Cycle Facility Operational Safety and Safeguards Inspection Program) has been revised to add a requirement for inspectors to review all open allegations pertaining to the inspection during inspection preparation. The revision also adds guidance on witnessing unsafe situations from NUREG/BR-0075, "Field Policy Manual."

The following inspection procedures have been revised to:

(1) emphasize the risk-informed, performance-based approach to inspection and (2) impose changes to inspection activities due to orders issued that have not been incorporated by rulemaking:

IP 81335 (Physical Protection of Shipments of Special Nuclear Material of Moderate Strategic Significance (SNM-MSS))

IP 81360 (General Requirements for Physical Protection of Formula Quantities of Special Nuclear Material in Transit)

IP 81431 (Fixed Site Physical Protection of Special Nuclear Material of Low Strategic Significance)

IP 81501 (Personnel Training and Qualification – General Requirements)

IP 71114.07 (Emergency Preparedness Component, of the Force-On-Force (FOF) Exercise Evaluation) has been revised to incorporate Commission guidance on inspection procedure information sensitivity designation.
