SUBJECT: SUMMARY OF NOVEMBER 19, 2009, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On November 19, 2009, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees discussed a revision to FAQ 09-0057 and their response to NRC comments on the previous revision. Licensees and the NRC staff discussed the remaining currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

The NRC staff described a potential new FAQ that deals with providing additional guidance for identifying the proper capability category for each of the supporting requirements identified in the ASME/ANS PRA Standard, as endorsed in Regulatory Guide 1.200, Revision 2. Additionally, the NRC staff noted that the NRC draft interim position on a FAQ (08-0051) related to NUREG/CR-6850 was available for public comment, and noted that licensees would be given the opportunity to ask clarifying questions at the next FAQ meeting.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place on December 17, 2009, at NRC headquarters.
