Dear Sir:

This application serves to amend certain sections of Appendix A to the Operating License in accordance with the requirements of Generic Letter No. 83-37 regarding NUREG-0737 Technical Specifications.

Attachment A to this letter contains an item by item discussion of the Technical Specifications requested in the Generic Letter. The proposed page changes to the Technical Specifications are included in Attachment No. 1 and the Safety Evaluation for the proposed changes are included in Attachment No. 2 of the enclosed "Application for Amendment to Operating License". Enclosed for filing are three (3) signed originals and nineteen (19) copies of a document entitled "Application for Amendment to Operating License", together with forty (40) copies of Attachment Nos. 1 and 2 thereto, comprising the revised Technical Specification pages and the associated Safety Evaluation.

The proposed Technical Specification changes are being submitted in response to a request from the NRC staff and serve to clarify the existing Specifications. Therefore, the Authority has determined that this application for amendment of the Technical Specifications is exempt from a licensing fee per Footnote 2 to 10 CFR 170.22.

It is requested that the proposed changes to Section 6 of the Technical Specifications be coordinated with the additional changes proposed in the Authority's submittals dated July 21, 1982 (IPN-82-55), March 8, 1983 (IPN-83-21), May 3, 1983 (IPN-83-34) and September 30, 1983 (IPN-83-84).
