2. Oyster Creek -- Search For Tritiated Water Continues

(From Regional Call) -- The licensee will take the Condensate Storage Tank (CST) system out of service while in cold shutdown to replace a 10 foot section of 8 inch carbon steel piping on the hotwell reject line to the CST. The licensee believes that this section may be a source of the leakage of tritiated water they have been experiencing. The licensee will also be capping a drain line in the condensate transfer building for repair after a boroscope inspection revealed possible deterioration. They have not ruled out leakage from a 6 inch aluminum line or a 10 inch line also associated with the condensate transfer building or the CST itself. Once the repairs on the 8 inch line are completed, further investigation of the source of the leakage will not be startup limiting. Pass to Oyster Creek License Renewal PM (Lisa Regner), and to the IRIB Tritium contacts (Steven Garry, Richard Conatser). Assigned to Rebecca Sigmon.
