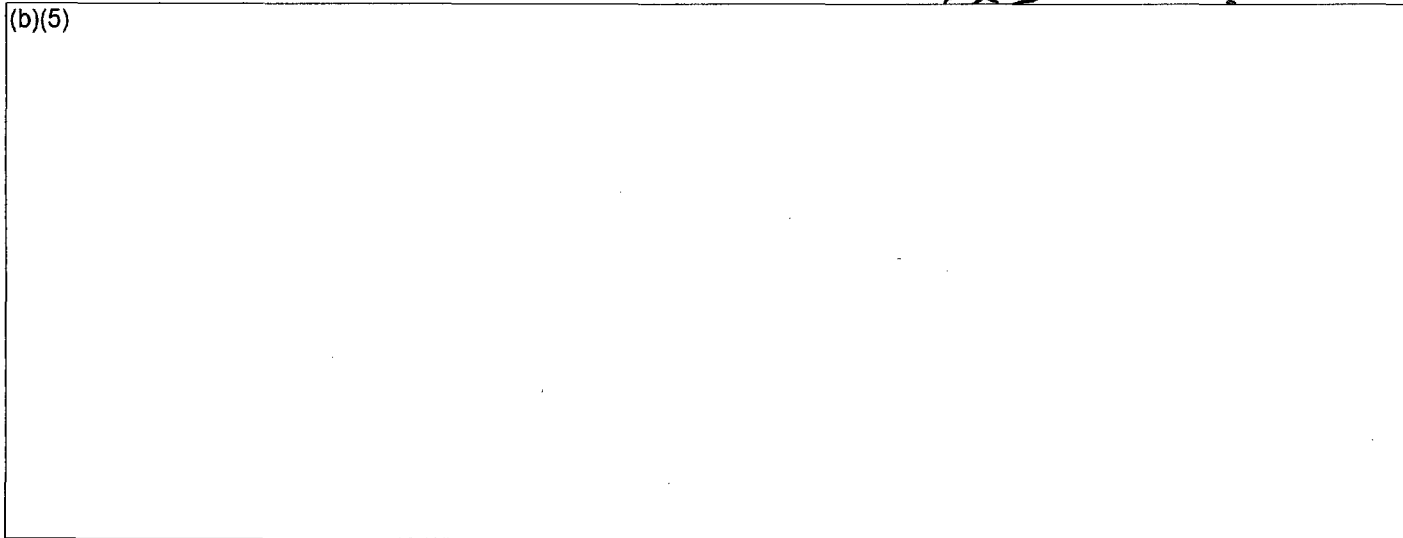
Harold, Joe:
