Fire Protection Meeting on National Fire Protection Association (NFPA) 805 Frequently Asked Questions (FAQs)

On November 19, 2009, staff held a Category 2 public meeting with the Nuclear Energy Institute (NEI) NFPA Standard 805 Task Force, other stakeholders, and the public to discuss the FAQs related to licensees' adoption of NFPA 805. The staff began holding these monthly public meetings in July 2006 and expects to continue holding them at least throughout the transition period for the pilot plants adopting NFPA 805.

Issuance of the Renewed Operating Licenses for Susquehanna Steam Electric Station, Units 1 and 2

On November 24, 2009, the operating licenses for Susquehanna Steam Electric Station, Units 1 and 2, were renewed authorizing operation for an additional 20 years beyond the original license expiration date. The new expiration date is July 17, 2042, for Unit 1, and March 23, 2044, for Unit 2. The staff completed the review as documented in the safety evaluation report, NUREG-1931, published November 2009, and the supplemental environmental impact statement, NUREG-1437, Supplement 35, published March 2009. The issuance of the Susquehanna Steam Electric Station, Units 1 and 2, renewed licenses, brings the total number of renewals to 59 reactor units.

Shuttle Bus Support Services

On November 24, 2009, as a result of a negotiated procurement under the 8(a) Section of the Small Business Act, a fixed priced contract (NRC-10-10-375) was awarded to Blue Ridge Limousine and Tour Service, Inc. in Springfield, Virginia, for NRC Headquarters shuttle bus support services. The contractor will provide local transportation via shuttle buses to various NRC Headquarters locations and to special events. The period of performance is one base year from December 1, 2009, through November 30, 2010, with two option periods. The total estimated cost of the contract, inclusive of options, is \$2,662,536.78.

Executive Director for Operations (EDO) Decision on Differing Professional Opinion (DPO)
2008-001 Appeal: Closure Process for Generic Safety Issue (GSI)-191

On November 20, 2009, the EDO issued a decision on the appeal of DPO 2008-001. The DPO submitted on October 1, 2008, stated that the closing approach to GSI-191 has resulted in an unnecessary review focused on compliance instead of the determination of the underlying safety issue. Furthermore, the DPO stated that the approach is inconsistent with Commission guidance on efficiency and focuses on non-safety significant issues. The DPO suggested that the NRC should defer compliance determination until a later date and that GSI-191 should be effectively closed.

To address GSI-191 closure, the NRC issued Generic Letter (GL) 2004-02, which required licensees to conduct analysis and perform modifications as necessary to assure long-term recirculation capacity of the emergency core cooling and core spray systems. The Office of Nuclear Reactor Regulation DPO Panel concluded that the staff's approach for resolving GSI-191 was appropriately focused and consistent with Commission guidance. In his decision, the EDO stated that the approach could have been better and that there are lessons to be learned. The EDO concluded that the staff continues to make progress towards the ultimate closure of GSI-191, and there is no compelling reason to change the agency's approach.
