Attached for your review is the updated Indian Point 3 Inservice Pump and Valve Testing (IST) Program for the second 120-month interval. Also provided is a comparison of the additional action items listed in the first ten year (1st 10yr) Safety Evaluation Report (SER) to the second ten year (2nd 10yr) IST Program.

Attachment 1 provides the Inservice Testing Program Plan effective through August 31, 1997 and updated to the requirements of Section XI of the ASME Boiler and Pressure Vessel Code, 1983 Edition.

Attachment 2 compares differences between the 2nd 10yr IST Program and the testing conditions described by the additional action items in the "Conclusions" section of Reference (1). Also included are responses to the requests for additional information in the 1st 10yr SER which are referred to as open items by Reference (1).


